Case History

In 2019, several class action lawsuits were filed alleging the Defendants combined or conspired to fix, maintain, or stabilize prices of HDD Suspension Assemblies sold in the United States in violation of state antitrust laws. It is impossible to predict the outcome, but money may become available to End User Class and/or Reseller Class if the classes are certified and settlements are reached with the Defendants in the future. FRS will update this Summary as the case progresses and new information becomes available.

Definition of “HDD Suspension Assemblies”: HDD Suspension Assemblies are a critical component of HDDs, which are incorporated into electronic devices, such as desktop computers, laptops, gaming consoles, printers, copy machines and MP3 players, or sold as stand-alone storage servers. HDDs use recording heads to read from and write onto spinning disks contained in the HDD. An HDD Suspension Assembly is the electro-mechanical component that holds a disk drive's recording head at a microscopic distance above the drive's disks.

Definition of “Standalone Storage Device”: Standalone Storage Devices are storage products comprised predominantly of HDDs. This includes personal HDD storage devices and enterprise HDD storage systems. Personal HDD storage devices include (i) “bare” HDDs, which are purchased for installation in a storage device or computer; (ii) external hard drives, which consist of an HDD, a simple USB adapter and/or power cord, and plastic housing; and (iii) network attached storage (NAS) drives, which are similar to an external hard drive but have a separate power supply and some additional hardware and/or software features. Enterprise HDD storage systems are storage servers and storage arrays, and include bare HDDs purchased for installation in the systems. Enterprise HDD storage systems are manufactured by a limited number of companies including BlueArc, Cisco Systems, Dot Hill, EMC, Isilon, LSI, NetApp, Seagate, Sun Microsystems/Oracle, Western Digital and Xyratex.
